


Figure 1 : Conceptual Framework




Figure 2 : Corporate social responsibility (CSR)




Figure 3: Corporate social responsibility towards the moral




Figure 4 : Corporate social responsibility towards the ethics.




Figure 5 Corporate social responsibility towards the achievement of learning which includes cognitive and adoption.




Figure 6: The main issues of corporate social responsibility (CSR-DIW 26000,2008).
